Reporting to the Charge Technologist, the Ultrasound Technologist performs medical imaging procedures to aid in patient diagnosis or treatment within the regulatory standards of practice. Assists the Radiologist during diagnostic procedures. Assesses the patient's condition prior to, during and after procedures, recognizing the conditions requiring immediate attention and initiating a response. Documents procedures and maintains accurate records. Observes and understands hospital and departmental policies and procedures. Maintains and protects patient confidentiality and safety. Performs other duties related to the job classification, as required.
